
# Unfulfilled welfare promises Village Temple Priests' Assn criticises TN Govt

Chennai, Jan 30: The Village Temple Priests' Association has accused the Tamil Nadu government of failing to fulfil its electoral promises to village temple priests, while announcing enhanced welfare measures for Islamic religious scholars (ulamas).

In a statement, the Association's Managing Trustee S. Vedantham and Trustee R.R. Gopalji said Chief Minister M.K. Stalin, during the Indian Union Muslim League's Mahalla Jamaat Coordination State Conference, announced several welfare measures for registered ulamas under the Tamil Nadu Waqf Board. These include increasing their monthly pension from Rs 3,000 to Rs 5,000, raising family pension from Rs.1,500 to Rs.2,500, and doubling the two-wheeler subsidy for 1,000 ulamas from Rs 25,000 to Rs 50,000, among five key announcements. The Association said

it has been demanding a monthly salary of Rs 10,000 for poor village temple priests enrolled in the Village Temple Priests Welfare Board, along with a pension of Rs 5,000 for retired priests above 60 years and a family pension of Rs 2,500. It noted that the DMK, in its 2021 Assembly election manifesto, had promised to enhance salaries and pensions for village temple priests and increase the number of pension beneficiaries to 10,000. However, the Association alleged that the DMK government,

rearing the end of its five-year term, has not implemented these promises. It claimed that despite the presence of nearly 3.9 lakh village temples across Tamil Nadu-most of them folk and guardian deity temples the number of beneficiaries under the welfare board has been kept below 10,000. The statement also criticised the government for not expanding the "Oru Kala Pooja" (single-time daily worship) scheme beyond about 17,000 temples and for not implementing the manifesto promise of allocating Rs 1,000

crore from public funds to renovate dilapidated temples under the Hindu Religious and Charitable Endowments Department.

Calling the government's actions discriminatory, the Association alleged unequal treatment of Hindu temple priests compared to other religious groups. It urged the Chief Minister to announce the implementation of the manifesto commitments for village temple priests before the election schedule is announced, to prove that the government stands by its promises.
